FORM OF CONTRACT AGREEMENT

THIS AGREEMENT made on the 3rd day of June 2022, between District Council, Unit Hafizabad (hereinafter "the Purchaser"), of the one part, and M/s Hinopak Motors Limited (hereinafter called "the Supplier"), of the other part:

WHEREAS the Purchaser invited supplier for the purchase of Vehicles/Vehicle's Chassis for the project "Provision of Machinery & Equipment for Improvement of Solid Waste Management in Hafizabad City" and has accepted the Quotation submitted by the Supplier for the supply of 11 Nos. HINO Truck Chassis in the sum of Rs. 80,230,000/- Eighty Million Two Hundred Thirty Thousand only (Hino Truck chassis of Rs. 79,130,000/- Seventy-Nine Million One Hundred Thirty Thousand only and Transportation charges of Rs. 1,100,000/- One Million One Hundred Thousand only) (hereinafter called "the Contract Price") as per following details:

This Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.

3. In consideration of the payments to be made by the Purchaser to the Supplier as indicated in this Agreement, the Supplier hereby covenants with the Purchaser to provide the Machinery / Equipment and to remedy defects therein in conformity, in all respects, with the provisions of the Contract.
4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Machinery / Equipment and the remedying of defects by the supplier therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
