

2 PROCESS FOR SELECTION OF CONTRACTOR:

2.1 Evaluation Committee

As per Consultants TOR's, Technical and financial evaluation of bids was conducted by M/s Jers Consultancy and the results are being formulated in this report for further scrutiny of this report by the evaluation committee members constituted by Concerned MC.

2.2 Financial Bid Opening:

After the technical evaluation, invitations were issued to the technically qualified bidders to attend the financial bid opening (**Annexure-A**) held on April 27, 2023 at 12:30 pm in the office of Administrator, Municipal Committee Hafizabad in the presence of bidder's representatives and Procurement committee. The financial bid was opened and signed by the all-present stakeholders. Financial bid of unsuccessful bidder was returned unopened to authorized representative of the firm, before opening of bids. . 3 RESULTS

Three (3) Nos. Contractors / Firms were pre-qualified for the said subproject. Financial bids of all four bidders were opened on the said date and time. Financial comparative statement is prepared according to financial bids of M/s Mian Abdul Razzaq Construction and M/s Mastic Construction. After detailed evaluation by applying arithmetic check, financial evaluation Statement shows that the bid quoted by M/s Mian Abdul Razzaq is 2.88 % above the estimated cost and he is found responsive and 1st lowest bidder. The case is hereby submitted for further processing to MC Hafizabad after fulfilling all codal and financial formalities.

Note: M/s Mushtaq has written imbalance unit rates as well as its line items amounts due to which there is huge difference between calculation and quoted values.

Note: Bidder has quoted imbalance rates in his bid due to which difference in calculations is found too high.

Conclusion: Three (3) Applicants were technically qualified by the MC Hafizabad on basis of technical evaluation. Financial bid of technically qualified bidders were opened on said date and time. After detailed financial evaluation by applying arithmetic check as per IB Clause 27 of bidding documents, bid amount determined of bidder i.e. M/s Mian Abdul Razzaq Construction Pvt Ltd is 2.88% above than the estimated cost and within permissible limit. The case is hereby submitted to MC Hafizabad for further processing. It is pertinent to mention that M/s Mushtaq & Sons has quoted imbalance unit rates as well as its line item amounts due to which the behaviour of bidder seems unprofessional and non-serious. A clarification may be sought from M/s Mushtaq & Co. regarding such kind of poor working failing which he may be debar from future tenderings especially on PCP subprojects.

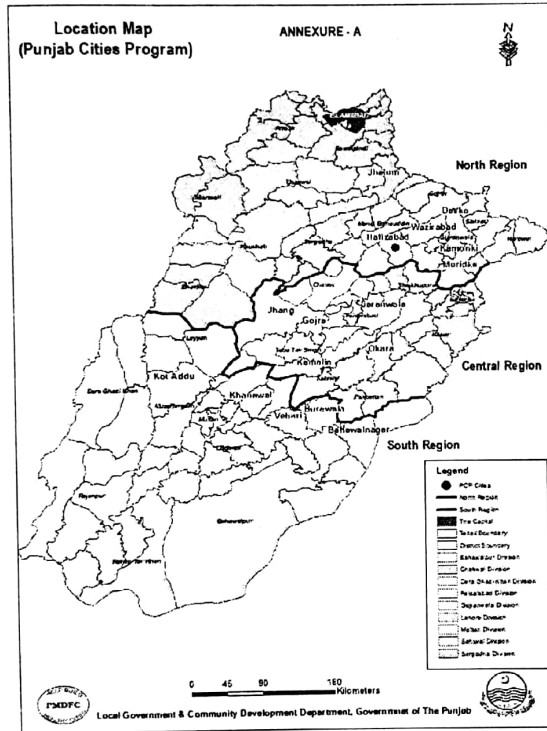

1 INTRODUCTION

1.1 General

With 110 million inhabitants (census 2017), Punjab is by far the most populated province in Pakistan. Punjab is Pakistan's second largest province by area after Baluchistan with an area of 205,344 square kilometers (79,284 square miles). It occupies 25.8% of the total landmass of Pakistan. Punjab has nine divisions as shown in map below and 36 districts.

The Punjab Cities Program (PCP), is a World Bank-funded hybrid of Program for Results (P for R) and Investment Project Financing (IPF) operation, with total cost of USD 200 million over 5 years (2018 -2023) supporting 16 cities in Punjab. Its development objective is to strengthen the performance of participating Municipal Committees/Corporations (MCs), focusing on urban management and improvement of municipal infrastructure for satisfactory service delivery.

Depending on geographical locations, 16 selected cities have been divided in 3 zones detailed hereunder:

Municipal services sub projects are planned in these 16 cities in various sectors including solid waste management, Roads, Cross roads, street lights, and Parks.



The project has been targeted in five different sectors i.e. Rehabilitation of Municipal Services of Infrastructure, Solid Waste Management Roads and street lights, Crossroad, Chowks, Important Nodes, and Parks with different type of services to be given by consultant.

A notification No.SOR (LG) 38-3/2017 dated 30.06.2023 was issued for re-inviting the Bidders for "Improvement of Jalalpur Road in Hafizabad city" circulated by MC Hafizabad to invite Eligible Bidders was published in widely circulated national newspaper (Annexure-A) and the application were opened on 05-04-2023 at 12:00 PM in the presence of procurement committee representatives.




